## Limitation of Warranty.

Failure to make any claim in writing, or within such five (5) business day period shall constitute an irrevocable acceptance of the Goods and an admission by the Buyer that the Goods fully comply with all terms, conditions and specifications of Buyer's order.

- Any faults relating to the Buyer-supplied material for COM/COL Customized Goods.

(c) Seller makes no other warranty or representation with respect to the Goods, either express or implied, including without limitation, that of merchantability or fitness for a particular use, or of any factors of quality, except as provided herein. The foregoing constitutes Buyer's sole and exclusive remedy and Seller's sole obligation with respect to Goods furnished hereunder. The parties agree that the burden of proving any bad practice on the part of Seller will be borne in full by the Buyer. Note that descriptions of Goods in Seller's catalogues or ether illustrative publications are given as an approximate indication and any divergences may not be considered as non-conformity. Conformity to a sample, if specified, must take into account the tolerances inherent in the use of natural materials (such as hide, leather, wool, wood, etc.) which do not give uniform results.
